As **Deputy Head of Boarding** in Wadeye you will be critical in managing and supervising the day to day operations of the hostel to ensure appropriate pastoral care is provided to students. You will be a leader for the Residential Youth Workers and key contact for students, teachers, parents and stakeholders. You will have prior management experience and be able to manage staff matters as well as difficult student situations and behaviours.

This commitment will be shown by your capacity to: <ul style="list-style-type: none"> • Understand Aboriginal and Torres Strait Islander peoples and cultures • Identify issues affecting Aboriginal and Torres Strait Islander peoples today • Communicate respectfully. • Ability to uphold ethical youth worker practices and principles including: <ul style="list-style-type: none"> • Young people as the primary consideration and the duty of care of young people; • Privacy, confidentiality and appropriate boundaries; • Transparency, honesty and integrity; • Awareness of social and cultural contexts; • Cooperation and collaboration; • Managing self-care needs.
2. Skills and Experience	<ul style="list-style-type: none"> • Proven capacity to manage the day-to-day operations of a Secondary Education Hostel, overseeing support for students within a boarding environment as well as staff and property matters; • Proven capacity to manage the development and delivery of programs for secondary education students within a boarding environment; • Knowledge and understanding of engagement, attendance and learning initiatives for Aboriginal and Torres Strait Islander students, in particular, for students living in a boarding environment away from community; • Proven ability to work autonomously and with accountability, demonstrating an in-depth knowledge of how to lead, support and coordinate a diverse team whilst striving for high performance. • You must also demonstrate a detailed understanding of Work Health and Safety practices including Child Protection, and be committed to operational needs, performing additional duties as requested.

Physical Requirements	<ul style="list-style-type: none"> • Incumbents need to be in good physical health. They will be required to walk, lift and carry, work a flexible schedule, and must be able to move continuously during working hours.
Essential Qualifications	<ul style="list-style-type: none"> • Diploma in Boarding Residential Care or equivalent qualification and/or relevant experience • Valid Working With Children Check in the relevant state or ability to obtain prior to employment • Current Senior First Aid Certificate or willingness to obtain one • Current Bus License for light-rigid vehicles (up to 25 seats) or willingness to obtain one.
Desirable Qualifications	<ul style="list-style-type: none"> • Mental Health First Aid Certificate. • Bronze Medallion (for hostels with swimming pools or regular water activities)

Requirements for employment

- meet fitness for duty requirements.
